### **MARKETING UPDATE**

Wendell Falls currently has over 500 homeowners and over 600 homes sold! We have sold 213 homes in 2018 and exceeded our sales goal!

Our new Model Village opened in conjunction with the 2018 Parade of Homes. All 8 entered Wendell Falls homes won Gold or Silver awards!

Wendell Falls is the #4 top selling community in the Triangle, which equates to 16 percent of the market share in Eastern Wake county, according to Metrostudy 3Q18.

We hosted another successful Farmhouse Jams on September 8th with over 300 attendees, and our first annual Trick or Trot 5K on October 27th with 68 registered runners.

### **CONSTRUCTION UPDATE**

Our oldest phases (SF-1, SF-2, and SF-3) are currently paved or in the process of being final paved, with the goal to be complete shortly after Thanksgiving.

Phase 5E was recently platted adding 68 more lots to the various builders lot inventory. Home construction will commence in the coming weeks/months.

Phase 6B is nearing completion and will be delivered before end of 4Q 2018, with home construction starting early 2019.


Phase 8 clearing, grading, and erosion control is underway with the first lot deliveries coming online Summer 2019. Phase 8 in its entirety is just over 300 lots and will be delivered in several sub phases.

## **COMMERCIAL UPDATE**

- Davis Development has closed on 12.924 acres on the backside of TreeLight Square for 288 multi-family units likely to begin construction later this year.
- Cruizers had its grand opening of Wendell Falls first commercial offering October 27th
- Rainbow Childcare is well into framing of the daycare and is currently scheduled to open in late May 2019
- The Wake County Public Safety Building which will incorporate Fire Department and EMS is currently scheduled to start construction in February 2019 with a 12 month construction completion schedule.
