MARKETING UPDATE

Wendell Falls currently has 577 occupied homes and 661 homes sold. We finished 2018 with 38% more sales than 2017, and have 40 sales so far this year!

We are very excited to announce Wendell Falls moved up to the #3 community in the Triangle, according to MetroStudy 4Q18.

The Spring Open House Tour was successful, attracting over 100 new guests to the community. Capitol City Homes also debuted their new model,The Boone, in conjunction with the tour.

CONSTRUCTION UPDATE

Phase 5F is in progress and lots will be delivered early summer 2019. Completion will bring Big Falls Drive tie-in into Martin Pond Road.

Phase 6B is complete with home construction underway.


