## **MARKETING UPDATE**

Wendell Falls currently has 696 occupied homes and 796 homes sold. We have sold 182 homes this year and are ahead of pace to meet our 2019 sales goal!

The much anticipated Farmhouse Café opened September 16th. Follow them on social media to stay in the know about their weekly/monthly events and menu specials.

Wendell Falls has 8 homes in the 2019 Parade of Homes this year- including Mattamy Homes' newest model, The Camden.

### **CONSTRUCTION UPDATE**

The first lots in Phase 8 (townhomes and alley loaded product across from the Farmhouse) have been delivered. The second section of that phase will be delivered in about a month.

The remaining portions of Phase 8 will come online mid 2020.

Phase 4 final lift of asphalt is complete.

We are expecting permits to begin construction of Phase 7 (across Poole Road at southeastern corner of Wendell Falls) later this fall, with early clearing and grading to start this winter.


The Big Falls connection to Poole Road will be completed in the next 3-4 months.

Construction of the Wake County Public Safety building continues with an anticipated completion in 1Q20.

Davis Development construction has begun.

Planning and design for additional road and utility infrastructure to support TreeLight Square has begun.

K-8 Charter School construction will begin 1Q20.

Permit approvals for the extension of Wendell Valley Blvd. to Knightdale Eaglerock Rd. is anticipated any day, with construction planned to begin in 1Q20.
