#### **CONSTRUCTION UPDATE**

Phase 9B lots have been contracted to builders. Expect to see home construction starting later this month. This phase has a total of 168 homesites, with a mix of front-load and rear-load products.

The amenity building and home construction are underway at Encore by David Weekley, the 55+ active adult community in Phase 7A (109 homesites).

Phase 12, located adjacent to Treelight Square, is bustling with activity from builders. This phase has 136 homesites and will also be the location of the future model park. Homes By Dickerson and Garman Homes will be debuting their brand new, three-story urban townhomes here, along with the introduction of McNeill Burbank's Cottage Collection.

The Richardson tract (corner of Martin Pond Rd. and WF Pkwy.) is being cleared and graded. This is a multi-family site with four retail parcels, one of which will be Neuse River Veterinary Hospital and dog daycare. Currently, the vet is open and working out of the white house on the corner until their building is complete.

Clearing is in progress for The Collective (large commercial section across from Cruizers) and clearing/grubbing should be finished up by the end of the year. The Collective will bring a variety of medical, technical, and professional services to residents.
