### **CONSTRUCTION UPDATE**

With pumpkins and mums filling up porches and leaves starting to show off their beautiful colors, it's no surprise that fall is one of our favorite seasons at Wendell Falls!

Homebuilding is well underway in Phases 9B, 9C, and 12. Lots of construction activity is happening in Ph 12, which is where the new model park is located, including the brand new Park Ave townhome model from Homes By Dickerson.

Phase 10B development is in progress with the first 119 single-family homesites being delivered to builders in late fall 2022. Sitework on Phase 11 and the remaining Phase 10 homesites is underway and expected to be delivered to builders in 2023. Phase 7B (the remaining lots in Encore) will be delivered early next year.

The permit for the tunnel under the parkway has been received! We have contracts out for grading and lighting and anticipate the pathway to be complete by early next year.
